**RESOLUTION SUPPORTING THE MOSS BEACH SR-1 CONGESTION AND
SAFETY IMPROVEMENTS PROJECT AND AUTHORIZING SUBMITTAL OF AN
APPLICATION FOR 2021 MEASURE A AND MEASURE W HIGHWAY PROGRAM
FUNDING AND COMMITTING TO THE COMPLETION OF THE PROPOSED
PROJECT SCOPE**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County of San Mateo Planning and Building Department (Department) developed a draft San Mateo County Midcoast Comprehensive Transportation Management Plan (CTMP or “Connect the Coastside”) to improve safety and mobility and address the requirements of County Local Coastal Program Policies 1.23 and 2.53; and

WHEREAS, through the development of Connect the Coastside, the Department has identified roadway safety and congestion concerns in Moss Beach along Highway 1 (SR-1) from 16th Street to Cypress Avenue in the State of California Department of Transportation (Caltrans) right-of-way; and

WHEREAS, Connect the Coastside recommends various transportation improvements to address the identified roadway safety and congestion concerns in Moss Beach along Highway 1 from 16th Street to Cypress Avenue, including but not limited to: traffic signals, roundabouts, turn lanes, intersection consolidation, signage,

bicycle and pedestrian path, and bicycle lanes (the “Moss Beach SR-1 Congestion and Safety Improvements Project”); and

WHEREAS, Caltrans requires a project initiation document (PID) to achieve consensus on the purpose and need, scope, and schedule of a project prior to a proposed project advancing to the Project Approval/Environmental Document phase; and

WHEREAS, Caltrans District 4 staff has advised the Department to develop a Project Study Report-Project Development Support (PSR-PDS) as the appropriate PID for the Moss Beach SR-1 Congestion and Safety Improvements Project; and

WHEREAS, it will cost \$1,195,000 for the project initiation phase of the Moss Beach SR-1 Congestion and Safety Improvements Project; and

WHEREAS, the County wishes to sponsor the implementation of the project initiation phase of the Moss Beach SR-1 Congestion and Safety Improvements Project; and

WHEREAS, the County seeks \$1,070,000 for the project initiation phase of the Moss Beach SR-1 Congestion and Safety Improvements Project; and

WHEREAS, on June 7, 1988, the voters of San Mateo County approved a ballot measure to allow the collection and distribution by the San Mateo County Transportation Authority (TA) of a half-cent transactions and use tax in San Mateo

County for 25 years, with the tax revenues to be used for highway and transit improvements pursuant to the Transportation Expenditure Plan presented to the voters (Original Measure A); and

WHEREAS, on November 2, 2004, the voters of San Mateo County approved the continuation of the collection and distribution by the TA of the half-cent transactions and use tax for an additional 25 years to implement the 2004 Transportation Expenditure Plan beginning January 1, 2009 (New Measure A); and

WHEREAS, on November 6, 2018, the voters of San Mateo County approved a ballot measure known as "Measure W," which increased the sales tax in San Mateo County by 1/2 percent, and tasked the TA with administering four of the five transportation program categories pursuant to the Congestion Relief Plan presented to the voters; and

WHEREAS, the TA issued a Call for Projects for the Measure A and Measure W Highway Program funds on August 6, 2021; and

WHEREAS, the TA requires applicants for Measure A and/or Measure W funds to submit a resolution in support of the application, in this case for \$1,070,000 in Measure A Highway Program funds for the Moss Beach SR-1 Congestion and Safety Improvements Project; and

WHEREAS, the TA also requires applicants to submit a resolution committing to the completion of the proposed project scope, in this case the project initiation phase for the Moss Beach SR-1 Congestion and Safety Improvements Project; and

WHEREAS, if the TA Board awards Measure A and/or Measure W Highway Program funds to the Moss Beach SR-1 Congestion and Safety Improvements Project, the TA will require that the County commence work on the project initiation phase within one year of TA Board action.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors of San Mateo County:

1. Directs the San Mateo County Planning and Building Department to submit an application for TA 2021 Measure A and Measure W Highway Program funds for \$1,070,000 for the Moss Beach SR-1 Congestion and Safety Improvements Project.
2. Authorizes the Community Development Director, or designee, to execute a funding agreement with the San Mateo County Transportation Authority for the County of San Mateo to receive any Measure A and/or Measure W Highway Program funds awarded.
3. Commits \$125,000 in County matching funds for the completion of the Moss Beach SR-1 Congestion and Safety Improvements Project's project initiation phase, if awarded the requested TA Measure A and/or Measure W Highway Program funds.

4. Directs the County to commence work on the project initiation document within one year of receiving an award of Measure A and/or Measure W Highway Program Funds.
5. Take any other actions necessary to give effect to this resolution.
