**RESOLUTION APPROVING THE EAST PALO ALTO SANITARY DISTRICT'S REQUEST
TO MOVE THE ELECTION OF ITS BOARD OF DIRECTORS TO COINCIDE WITH THE
STATEWIDE GENERAL ELECTION (NOVEMBER OF EVEN-NUMBERED YEARS)**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on August 24, 2021, the East Palo Alto Sanitary District (the "District") adopted a resolution pursuant to Elections Code Sections 1303(b) and 10404 requesting that future elections of its Board of Directors be moved from the date of the Statewide Direct Primary to coincide with the date of the Statewide General Election, beginning November 8, 2022; and

WHEREAS, the next-scheduled election of the District's Board of Directors is June 7, 2022; and

WHEREAS, the District submitted its resolution to the Board of Supervisors on September 13, 2021, which is more than 240 days before the date of the District's next-scheduled election, and, to the extent Section 10404 applies, (1) the Board must notify all special districts located in the County of the receipt of the resolution and request input from each district on the effect of consolidation, (2) the County's Elections Division must prepare for the Board an impact analysis of the proposed consolidation; and (3) within 60 days from the date of submission by the District, the Board must approve the resolution unless it finds that the ballot style, voting equipment, or computer capacity is such that additional elections or materials cannot be handled; and

WHEREAS, in publishing notice of this item its meeting agenda, the Board notifies all special districts located in the County of the receipt of the resolution and requests input from each special district on the effect of consolidation pursuant to Elections Code Section 10404(c); and

WHEREAS, the Elections Division performed an impact analysis of the District's proposed change in election dates pursuant to Elections Code Section 10404(d) and has concluded that the change will not have a significant impact on ballot styles, voting equipment, or computer capacity, the requested change will increase the variation in the Sample Ballot & Official Voter Information Pamphlets and the Official Ballot types during the Statewide General Election, while reducing variation during the Statewide Direct Primary, and the variation in costs, if any, will be minimal.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors does not find the ballot style, voting equipment, or computer capacity of the Elections Division is such that additional elections or materials cannot be handled in relation to the District's request, and accordingly approves the District's request to that future elections of its Board of Directors be moved from the date of the Statewide Direct Primary to coincide with the date of the Statewide General Election, beginning November 8, 2022.

IT IS FURTHER RESOLVED that, within 30 days of the effective date of this resolution, the County's Elections Division will, at the District's expense, notify all registered voters affected by the approval of the District's request to that future elections of its Board of Directors be moved from the date of the Statewide Direct Primary to coincide with the date of the Statewide General Election, beginning November 8, 2022.
