Supervisor Don Horsley reported that he attended the Bay Area Flood Protection Agencies Association Conference on Sea Level Rise in Oakland on Feb. 19, 2015.

Supervisor Dave Pine made an observation on the County's Emergency Response protocols used at a local charter school in Redwood City and the quick response as a result of their use. He attributes the success of these protocols, in part, to the efforts made by Supervisor Horsley and Tissier in pushing them through.

Supervisor Warren Slocum recognized Jordon Fowler, a sophomore at the University of Southern California who resides in Redwood Shores and was a former 2013 Sequoia Award recipient, on being elected as student body vice-president. Her election marked USC's historic first all-female ticket elected for student office.

Supervisor Slocum also reported that the "Poetry is Love" contest is still on-going. Currently, 110 poems have been submitted with 56 from high school students and 20 from students in the elementary schools. Entries will be accepted until February 28th.
