  - A) Submit a grant application to the California Governor's Office of Emergency Services for the administration of FY 2015 Anti-Terrorism Funds in an amount not to exceed \$114,000; and
  - B) Execute, on behalf of the County of San Mateo, all necessary contracts, agreements, amendments, payment requests and grant assurances for the purposes of securing and expending funds that may be awarded pursuant to this grant application and implementing and carrying out the purpose specified in the grant application.
