Upon motion by Supervisor David Canepa, seconded by Supervisor Don Horsley and carried 4-1 with Supervisor Dave Pine dissenting to appropriate \$20 Million dollars in County funds with a request for the Heath Plan of San Mateo to contribute \$10 million of this amount to assist an entity to acquire and operate Seton Hospital/Seton coastside, subject to the following conditions: 1. Closing of a transaction between Verity and such entity that required the acquiring entity to continue to operate Seton Hospital as a full service hospital consistent with the California Attorney General's conditions; 2. Funds to be paid at a rate of \$5 million per year over 4 years beginning at sale close; 3. Funds to be appropriately secured, as determined by staff/counsel; 4. Acquiring entity continues to provide services that afford countywide public benefit; 5. Provision of satisfactory business plans and financials; 6. Negotiation of an appropriate form of agreement; and 7. Annual reporting in satisfaction of these conditions.
