G24-16446	Katrina King	1/14/2024	Non-culpable Claimant alleges that the County is responsible for injuries she sustained at 33 Mateo Avenue in Millbrae, after an altercation with a caregiver.
G24-16448	Shelby Blystone	2/19/2024	Non-culpable Claimant alleges loss of personal property while Claimant was incarcerated at Maguire Jail.
A23-157592	Naoko Okano-Mohan	10/8/2023	Non-culpable Claimant alleges that Sheriff's Office vehicle rear-ended a motor Vehicle waiting at a red light, which was pushed into Claimant's

vehicle.

- G23-16457 Tery Zlatunich 10/7/2023 Non-culpable
Claimant alleges that the County is responsible for injuries sustained when Claimant tripped over the warped and weathered wooden Bridge planks located at Bay Trail behind Kincaid's Restaurant.
- G24-16478 Howard & Barbara Kalt 2/28/2024 Non-culpable
Claimant alleges that the County is responsible for dangerous sidewalk condition where the roots of a redwood tree raised the public sidewalk, creating a 14-inch rippled drop from property line to curb, and cracked the private driveway.
- G23-16480 J'shun Cash 9/27/2023 Non-culpable
Claimant alleges that the County is responsible for a traffic collision that occurred while Claimant was a passenger in a vehicle that was struck by a San Mateo County Transit District ("SamTrans") vehicle on Junipero Serra Boulevard in San Francisco.
- G24-16496 Annie Tufenkji 3/21/2024 Non-culpable
Claimant alleges the County is responsible for the loss of her personal property at the San Mateo Medical Center.
