**Subject:** Appointments to the San Mateo County Veterans Commission

**RECOMMENDATION:**

Recommendation for appointments to the San Mateo County Veterans Commission:

- A) Mark McVay, representing Member, for an initial partial term ending June 30, 2024; and
- B) Caroline Schlocker, representing Alternate, for an initial partial term ending June 30, 2023; and
- C) Mary Cravalho, representing Alternate, for an initial partial term ending June 30, 2023.

**BACKGROUND:**

On June 2, 2015, the San Mateo County Board of Supervisors adopted Resolution No. 073812 establishing the San Mateo County Veterans Commission. The mandate of the Veterans Commission includes the promotion of programs and policies that address the unmet needs of veterans in San Mateo County, such as those identified in the 2014 San Mateo County Veterans Needs Assessment. In establishing the Veterans Commission, the Board specifically directed those efforts be undertaken to maximize the likelihood that the Commission's membership will reflect the diversity of veterans in San Mateo County, including with respect to race/ethnicity, gender, age and sexual orientation.

Subsequently, on November 3, 2015, the Board of Supervisors adopted Resolution No. 074159, which increased the membership of the Veterans Commission from nine to eleven regular voting members. Thereafter, on November 17, 2015, the Board of Supervisors adopted Resolution No. 074183 which expanded the membership of the Veterans Commission to include two alternate members.

**DISCUSSION:**

This recommendation is for the appointment of three Veterans Commissioners as noted above.

Mark McVay is being recommended to serve an initial partial term as a regular member on a seat formerly held by George Smith. Caroline Schlocker and Mary Cravalho are each being recommended to serve an initial partial term as an Alternate on seats formerly held by Ron Mussman and Kyle Corcoran, who are both regular members on the commission.

Mark McVay is a U.S. Navy veteran, who served honorably from 1986-1994, including time as a nuclear engineer on the aircraft carrier, USS Carl Vinson. After his discharge, McVay has held management positions in energy, data and Saas and as a volunteer for numerous causes. He currently serves as the Managing Director of the Net Zero Academy at the Stanford University Doerr School of Sustainability.

Caroline Schlocker is a U.S. Navy veteran who served honorably as a Navy surgeon for 16 years. She is currently a Surgeon and Professor in Otolaryngology at University of California at San Francisco.

Mary Cravalho is in private practice as a Marriage Family Child Counselor (MFCC) and Marriage Family Therapist (MFT). She has worked with a number of organizations including StarVista as a Family Counselor and Case Manager and Service League of San Mateo County.
