Subject: Agreement with Marta Banh, OD to Provide Optometry Services

RECOMMENDATION:

Adopt a resolution authorizing an agreement with Marta Banh, OD to provide optometry services for the term of October 1, 2018 through September 30, 2019, in an amount not to exceed \$150,000.

BACKGROUND:

San Mateo County is responsible for providing necessary optical care to its medically indigent population, and access to services to its general population. Dr. Banh has been providing optometry services at San Mateo Medical Center (SMMC) since October of 2013.

DISCUSSION:

The County's need for optometry services is increasing due to the aging of its patient population. SMMC will continue to meet this growing need through contracts with Dr. Banh and other optometrists. Dr. Banh has agreed to provide necessary diabetic retinopathy screening and optometry examination coverage for County patients.

County Administrative Memorandum B-1 provides that contracts for physicians are exempt from the Request for Proposals process.

The agreement and resolution have been reviewed and approved by County Counsel as to form.

The resolution contains the County's standard provisions allowing amendment of the County fiscal obligations by a maximum of \$25,000 (in aggregate).

The agreement contributes to the Shared Vision 2025 outcome of a Healthy Community by providing access to optometry services to County residents. It is anticipated that 100% of all eye examinations will adhere to the infection control standards as defined by the Joint Commission and Title XXII of the State of California, Code of Regulations, resulting in the reduced risk of healthcare-associated

infections.

PERFORMANCE MEASURE:

FISCAL IMPACT:

The term of the agreement is October 1, 2018 through September 30, 2019. The amount of the agreement is not to exceed \$150,000 for the one-year term. Funds in the amount of \$125,000 are included in the SMMC FY 2018-19 Recommended Budget.

Similar arrangements will be made for future years.

The payment provisions for this contract are essentially the same as the previous contract.

Expenses at SMMC are covered by fees for services or third-party payors whenever possible. The portion of expenses for services provided to the medically indigent or to those covered by programs that do not meet the full costs of care are covered by the County's General Fund contribution to SMMC, and are within the existing annual appropriation.
