**Subject:** Acceptance of Award from the California Department of Public Health Tuberculosis Control Branch for a Tuberculosis Prevention and Control Program

**RECOMMENDATION:**

Adopt a resolution authorizing the acceptance of an award from the California Department of Public Health Tuberculosis Control Branch to provide tuberculosis prevention and control activities for the term of July 1, 2021 through June 30, 2022, in an amount not to exceed \$347,499.

**BACKGROUND:**

The California Department of Public Health (CDPH) provides funding for Tuberculosis (TB) control activities including the investigation of potential cases and administration of the directly-observed therapy program. The increased TB transmission rate among homeless populations and in congregate settings such as shelters, prisons, and jails, high immigration rates of TB-endemic countries to San Mateo communities, as well as a general reduction in the national public health infrastructure supporting TB control activities, continue to be a challenge for San Mateo County and throughout the state of California.

**DISCUSSION:**

TB cases and their contacts are typically followed for six to twelve months and sometimes longer. Funding from this award will be used to offset the cost of three FTE of Community Workers. The TB staff will provide prevention and control measures including case management, contact investigation, and directly-observed therapy.

The resolution contains the County's standard provisions allowing amendment of the County's fiscal obligations by a maximum of \$25,000 (in aggregate).

The agreement and resolution have been reviewed and approved by County Counsel as to form.

It is anticipated that 100% of active TB cases will be case-managed by County Health's TB control

program to ensure that those patients are no longer infectious, with exposed contacts investigated and managed accordingly.

**FISCAL IMPACT:**

The term of the agreement is July 1, 2021 through June 30, 2022. The amount of the agreement is not to exceed \$347,499 for the one-year term. These funds are included in the Public Health, Policy and Planning FY 2021-22 Recommended Budget. Since the County is receiving these funds and no matching funds are required, there is no Net County Cost associated with this agreement.
